“When the doctor gave me the news, I was in denial... then I realised there were tears rolling down my face. To have the reassurance of my Cancer Society nurse Jan was amazing, she gave me support at a time when I really needed it.”

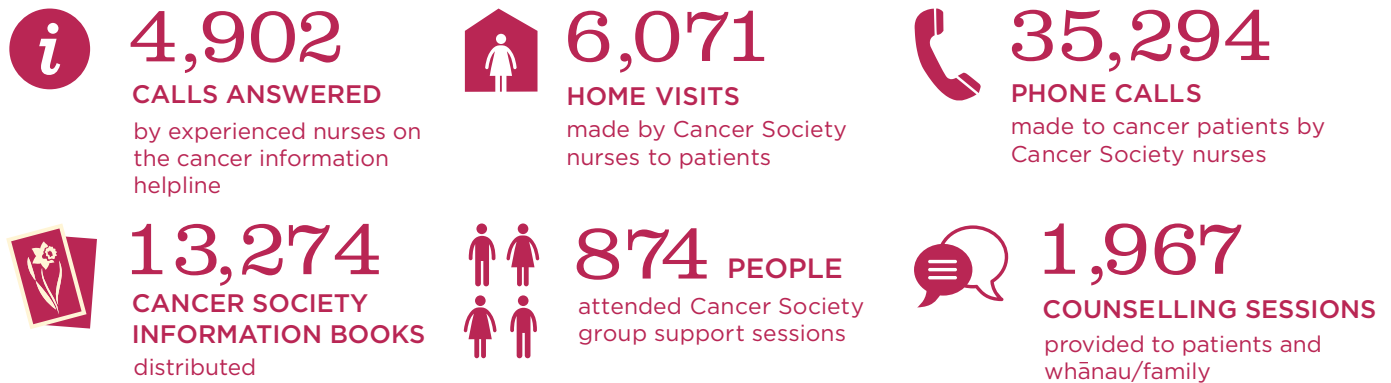
My cancer journey began in May 2015. I had just turned 45 and had my first free mammogram. The results were not good. I had stage 2 breast cancer. Three weeks later I was in surgery having a partial mastectomy. A week later I was told the cancer had spread to my first lymph node which required a second surgery. Thankfully the lymph nodes were clear. Then followed 12 weeks of chemotherapy and 6 weeks radiation.

During my treatment I was overwhelmed by support from family and friends, but also from Cancer Society. Having my nurse Jan come and check on me, especially after chemotherapy, was so reassuring. Until this happened, I didn't realise what services were actually available and how much assistance Cancer Society provides cancer patients. I couldn't have got through without them.

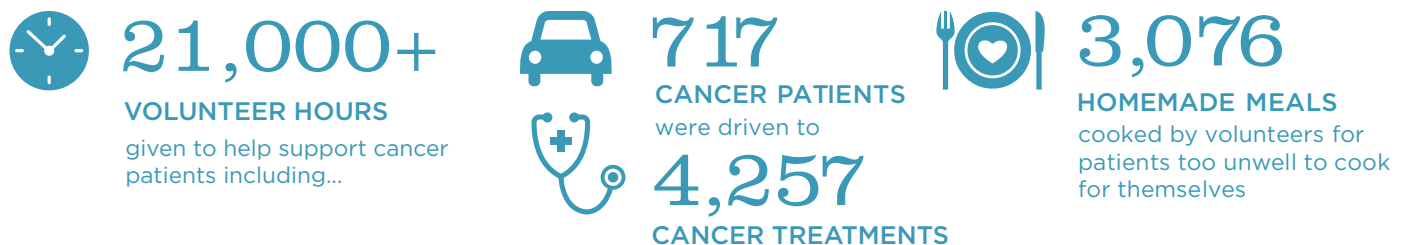

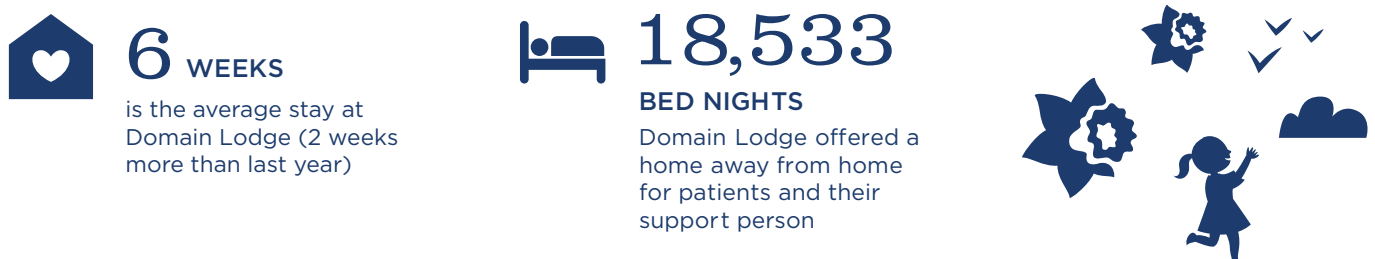

Volunteers provide essential support and practical help to cancer patients and whānau/families including:

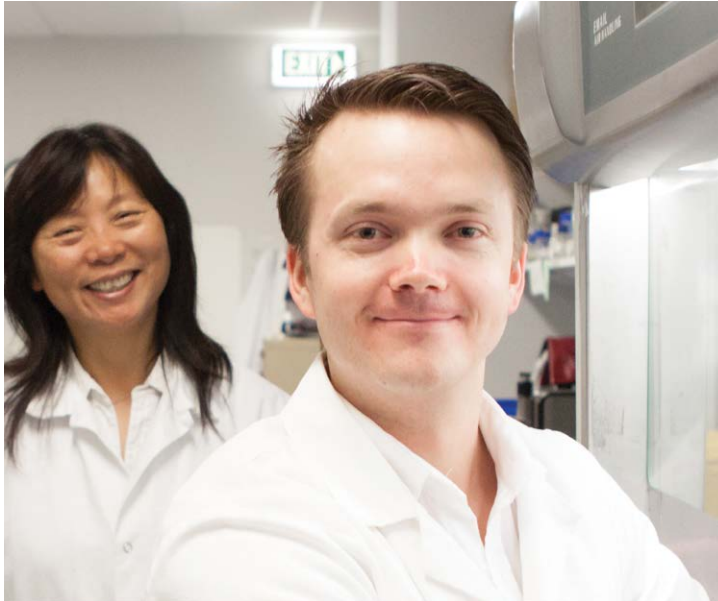


Domain Lodge

Summary Financial Statements

This is a summary of the Cancer Society of New Zealand Auckland Northland Division Incorporated's (formerly known as Cancer Society of New Zealand Auckland Division Incorporated) financial statements for the year ended 31 March 2016. The information was extracted from the full financial statements as audited by BDO Auckland, which were approved by the board on 21 June 2016. The audit report was qualified in the full financial statements in respect of certain donation income. This qualification is referred to in the Audit Report attached to these financial statements. The financial statements have been prepared in accordance with the Charities Act 2005 and generally accepted accounting practice in New Zealand. They comply with Public Benefit Entity International Public Sector Accounting Standards (PBE IPSAS) and other applicable Financial Reporting Standards, as appropriate for Tier 2 not-for-profit public benefit entities, for which all reduced disclosure regime exemptions have been adopted. The Group qualifies as a Tier 2 reporting entity as for the two most recent reporting periods it has had between \$2 million and \$30 million operating expenditure. These are the Society's and Group's first set of financial statements presented in accordance with PBE Standards. The summary financial statements have been prepared in accordance with PBE FRS-43: Summary Financial Statements. They cannot be expected to provide as complete an understanding as provided by the full financial report. The presentation currency is New Zealand dollars. All amounts are stated in \$000s.

REPORT OF THE INDEPENDENT AUDITOR ON THE SUMMARY FINANCIAL STATEMENTS TO THE MEMBERS OF CANCER SOCIETY OF NEW ZEALAND AUCKLAND NORTHLAND DIVISION INCORPORATED

The accompanying summary financial statements, which comprise the consolidated and separate summary statements of financial position as at 31 March 2016, and the consolidated and separate summary statement of comprehensive revenue and expense, statement of changes in net assets/equity and statement of cash flows for the year then ended, are derived from the audited financial statements of Cancer Society of New Zealand Auckland Northland Division Incorporated ("the Society") and its controlled entities (together "the Group") for the year ended 31 March 2016. We expressed a qualified audit opinion on those financial statements in our report dated 21 June 2016. Those financial statements, and the summary financial statements, do not reflect the effects of events that occurred subsequent to the date of our report on those financial statements.

The summary financial statements do not contain all the disclosures required for full financial statements under generally accepted accounting practice in New Zealand. Reading the summary financial statements, therefore, is not a substitute for reading the audited financial statements of the Society and the Group.

The Board's Responsibility for the Summary Financial Statements

The Board is responsible for the preparation of the summary of the audited financial statements in accordance with PBE FRS-43: Summary Financial Statements.

Auditor's Responsibility

Our responsibility is to express an opinion on the summary financial statements based on our procedures, which were conducted in accordance with International Standards on Auditing (New Zealand) (ISA (NZ)) 810 "Engagements to Report on Summary Financial Statements".

In addition to audit services, our firm provides other services in the areas of business advisory. We have no other relationship with, or interests in the Society or any of its controlled entities.

Opinion

In our opinion, the summary financial statements derived from the audited financial statements of the Society and the Group for the year ended 31 March 2016 are consistent, in all material respects, with those financial statements, in accordance with PBE FRS-43.

Our opinion on the audited financial statements was a qualified opinion based on the fact that control over income from Daffodil Day Appeal and donations of \$751,747 (2015: \$1,544,085), prior to being recorded is limited, and there are no practical audit procedures to determine the effect of this limited control. Accordingly the completeness of revenue and related cash flows is unable to be determined.

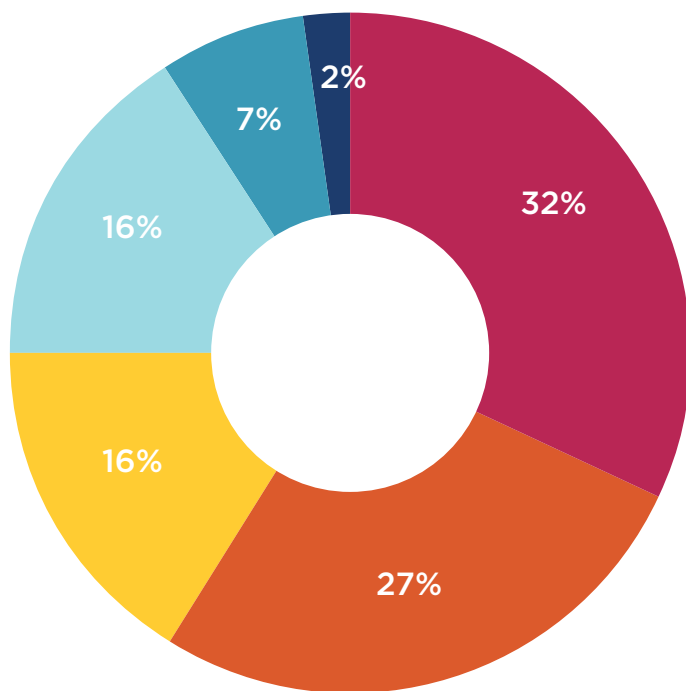
Our qualified audit opinion states that

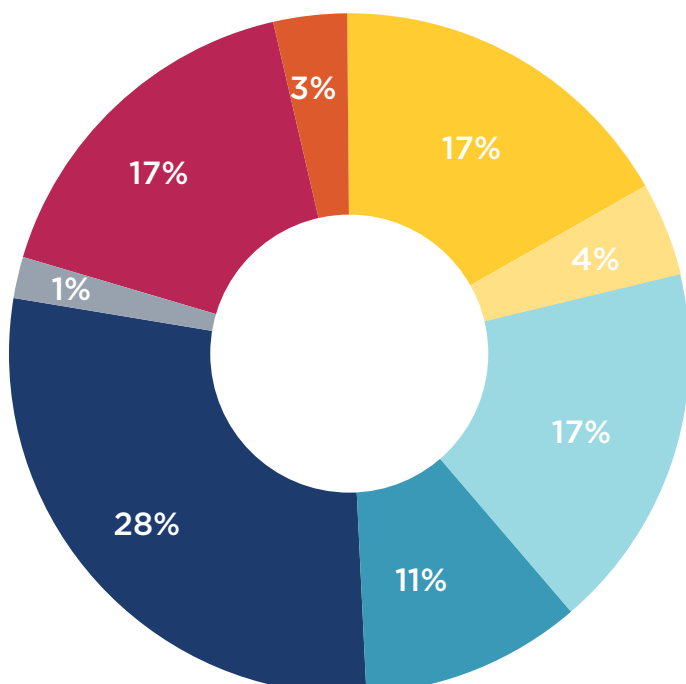
